Dear Chief Executive,

As we approach the establishment of the Social Partnership Council and the commencement of the Social Partnership Duty, I am writing to you to emphasise the value of trade union facility time.

We share a commitment to making Wales a fair work nation, and I am grateful for the part Welsh public bodies are playing in leading by example as employers. This includes the constructive relationships across our public bodies with recognised trade unions. Every worker has a legal right to join a trade union and we expect our devolved public bodies to provide trade union access, so workers have the opportunity and choice to be represented collectively. We would like you to remind your staff about the benefits of joining a trade union by urging them to use: <a href="Join a union | TUC">Join a union | TUC</a> and we would encourage you to promote trade union access in organisations you work with.

Our social partnership approach is underpinned by the benefits of employers and trade unions working as partners in a spirit of collaboration, shared commitment and mutual respect. For this to happen, there should be provision of appropriate, sufficient and agreed facility time. Whilst I appreciate the pressures facing public bodies, I encourage you to approach facility time as an investment which benefits you as an employer, as well as your workforce.

The Welsh Government considers the benefits of facility time to be far-reaching and include:

- Assisting the early identification and resolution of issues.
- Enhancing employee engagement and collaborative workplace cultures.
- Supporting health and safety and reducing the risk of work-related injuries and occupational illnesses.
- Aiding training and workforce learning and development.
- Facilitating effective negotiation processes.

I urge you to keep these benefits in mind when taking decisions on facility time and expect that you will discuss and agree any changes with your trade unions.

Difficult times such as we currently face should deepen our commitment to social partnership and shared decision-making rather than undermine relationships between employers and trade unions.
