Implications of a terminal diagnosis

Being told that you are to die as a result of a disease for which there is no cure or effective treatment and that you only have months, or at best a year or so to live is a traumatic event and everyone will react differently.

Sometimes the nature of the illness is such that the person is unlikely to be able to work again. In other cases, a person may decide that they do not want to work anymore and would rather spend their remaining time with their family and friends, getting their affairs in order, or simply doing what they want. However, a lot of workers with a terminal diagnosis decide that they want to continue working as long as they can, either because they need the financial security or because they find that their work can be a helpful distraction from their illness. Whichever choice a person makes, they should be able to expect help and support from their employer. Unfortunately the experience of many workers is that their employer is either unsympathetic or puts up barriers to them continuing in work.

If a worker with a terminal illness loses their job they lose their income. They can also lose any death in service payments they have earned through a life-time of work but are only payable to those that die while still in employment.

Did you know...

Cancer Research UK are projecting that 1 in 3 people will be diagnosed with cancer. Currently 1 in 10 new cancer cases are found in people under 50. (Over 33k cases a year)

THE WALES UNION LEARNING FUND



The Wales Union Learning Fund Connecting workers into learning for a more skilled, equal and prosperous Wales



WHAT IS THE WALES UNION LEARNING

FUND? The Wales Union Learning Fund (WULF) exists to support learning initiatives in unionised workplaces where employers recognise the benefits of working in partnership with unions to up-skill their workforce. It funds a range of projects which are led by different unions and promote workplace learning.

'Unionised' workplaces are those where the employer has officially recognised a union. This means the employer has a duty to consult and negotiate with the union on workplace issues. The collective negotiating power of the union helps workers to have their voices heard on issues such as pay, terms and conditions, safety at work, equality and workplace learning.

Trade unions have always led the way in ensuring equal and fair access to learning opportunities in the workplace. Where this is organised there are clear benefits for the whole workforce.

As can be seen from the examples in this booklet, union-led learning is a critical tool in developing the skills to create a flourishing, vibrant Welsh economy with well-paid, rewarding and sustainable jobs. It also plays a key role in promoting greater equality in our workplaces.

The Learning Services team currently supports 23 Wales Union Learning Fund projects across Wales. These projects are led by individual or small groups of unions and are funded by Welsh Government. The team also supports unions and employers to establish partnership arrangements, and provides training and development for the estimated 1000 union learning representatives who promote workplace learning in Wales.

> **HOW IS IT FUNDED?** WULF is funded by Welsh Government, and unions apply to run projects using the fund in a competitive bidding process. There are 23 WULF projects funded in the current round, with most projects funded until March 2018.

> Since its inception in 1999, WULF has received over £13 million from the Welsh Government and this has seen 185 successful and innovative WULF projects to date. The learning opportunities the projects provide are open to all employees within a workplace, whether or not they are in a union. The projects have been responsible for bringing successful workplace learning to tens of thousands of learners in Wales.







The Official Shrewsbury 24 Campaign

To Overturn A Miscarriage Of Justice

The Shrewsbury 24 Campaign - Judicial Review

The Shrewsbury 24 Campaign was established in 2006. Our aim is to overturn the convictions and sentences of North Wales building workers who took part in picketing during the 1972 national strike. Several of them were sent to prison. We have spent twelve years researching the background to the trials and have found fresh evidence to support the case. After five years deliberation the CCRC have refused to refer the case back to the Court of Appeal. We are currently challenging their decision by Judicial Review. We are supported by 21 national Trade Unions and many trade union branches, Trades Councils and Constituency Labour Party branches.

We are asking for affiliations and/or donations to help fund the legal case. We can provide speakers to conferences /branches etc.


