## TUC Young Workers' Conference 2017 Emergency Motions

## **Emergency motion 1: DWP Cuts**

Conference notes continued unprecedented attacks driven by an unpopular right-wing Government ideologically opposed to the public sector.

Announcements on 26 January confirmed 130 DWP sites have been earmarked for closure under the governments estates rationalisation programme. Many are local job centres, impacting the most vulnerable members of society.

A commitment given that no job centre would be closed unless another location was reachable within 20 minutes on public transport has already been breached no fewer than 20 times.

According to DWP statistics, 12% of 18-25-year-olds and 52% of young disabled people are unemployed. Furthermore, 18-25-year-olds make up the highest proportion of single parent benefit claimants. For those young people, additional travel on public transport will be problematic.

In addition to the detrimental impact on claimants, office closure programmes demonstrate the Government is set on destroying secure, reasonably paid jobs. The impact on local communities, society and the economy cannot be understated. It's clear that these closures will negatively impact on young workers.

Conference calls on the TUC to:

- Support the PCS local and national campaigns opposing office closures.
- Support the PCS political campaigns by lobbying MPs
- Produce literature highlighting the importance of access to public services

"No reference should be made to any affiliation with any political organisation"

Conference believes that this clause in McDonald's social media policy is an attempt to silence workers from discussing their trade union activity on social media.

Conference calls for its immediate withdrawal.
